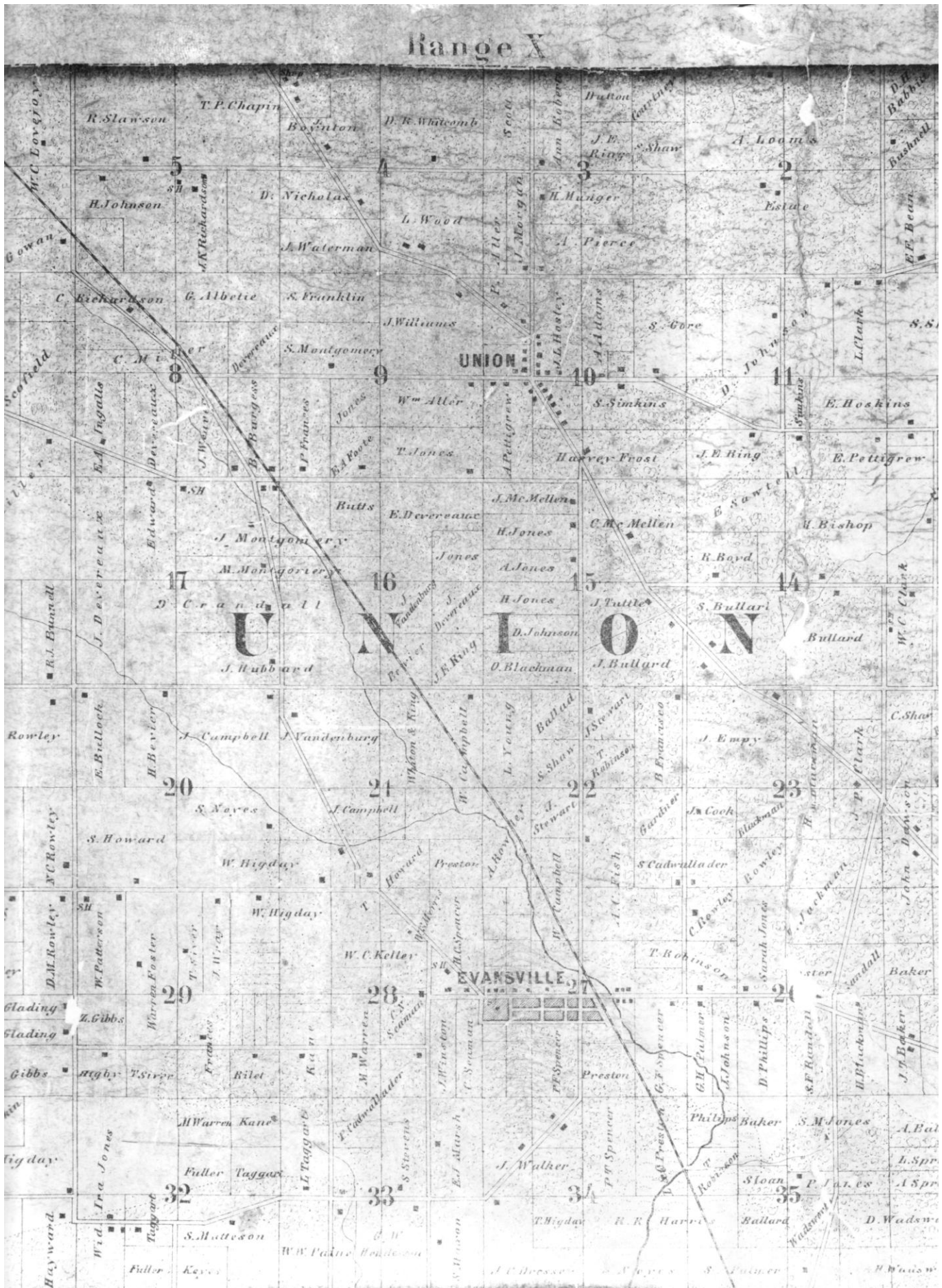

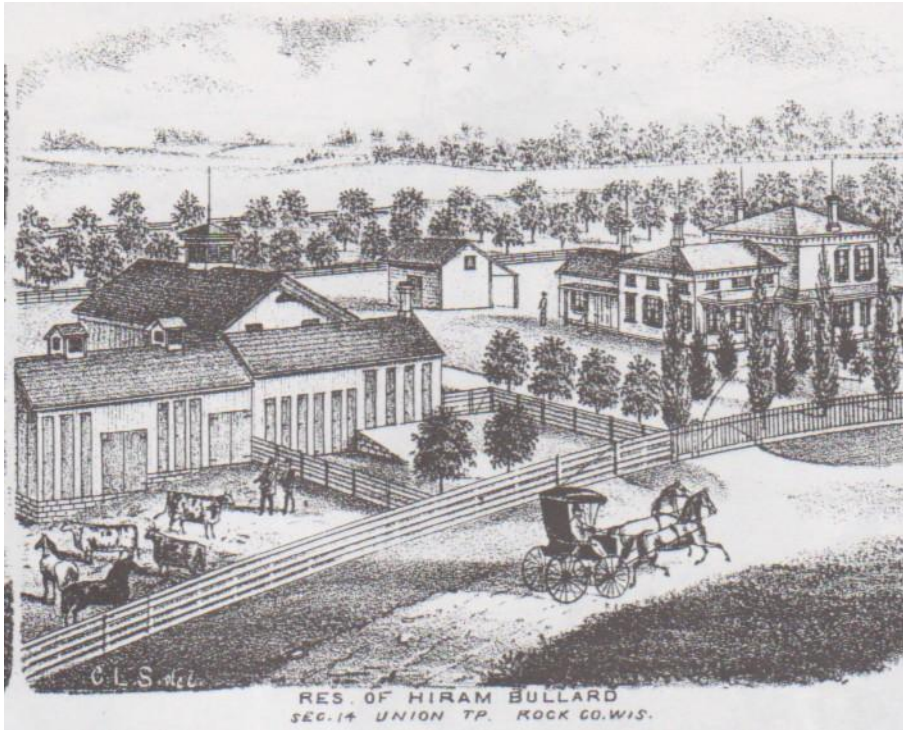

## DIED

**BULLARD.** In Union, Rock county, Wis., April 17, 1874, at her residence after a painful illness, Mrs. Mary E. Bullard, wife of Mr. Hiram Bullard, in the 46th year of her age.

Mrs. Mary E. Butterfield, the deceased, was born in Rodman, Jefferson county, N. Y., September 6, 1829. Her parents removed to Nunda, Livingston county, N. Y., when she was but a child. When she was sixteen years of age she was hopefully converted to Christ, and was baptized by Rev. T. H. Spoor, the pastor of the church at Nunda. She remained a faithful member of that church until after the death of her father, which occurred in 1845, when with her mother and others of the family and friends, removed to Fox Lake, Wis., and was one of the few that organized themselves into a Baptist church, which is now a large and flourishing church. She was a successful teacher, teaching in Randolph, Portage City and other places. She spent one year in Indiana, visiting and teaching. In 1847, she visited her native state, and was absent one year visiting the haunts of her childhood, and loved ones that she had been long separated from, not only her kindred, but friends of her early youth. Returning in 1858 she again assumed the duties of teaching until 1863, when she was married to Mr. Hiram Bullard, of Union, Rock county, Wis., and took upon herself the responsible duties of wife and mother. Uniting with the Baptist church at Union, she became an active member, a faithful and affectionate wife, a devoted mother, and by her Christian spirit endeared herself to all who knew her. In short, she was a friend to every one, and every one loved her. She was a faithful Sabbath-school teacher, and she leaves a stricken family, a vacant class and weeping church to mourn her loss.

Her funeral was attended by a large concourse of people, who partook of the general sorrow. Her funeral sermon was preached by Rev. H. Whitman, of Waupun, Wis., the former pastor of the church, from Number xxxiii, 10. "Let me die the death of the righteous and let my last end be like his," and as we laid her away, we felt to exclaim, "Weep not when a Christian dieth."

Mr. Bullard desires us to express his gratitude for many acts of kindness shown to him and his during the sickness of his wife, by friends and neighbors. Nothing was omitted that could relieve the burden of the afflicted or sooth the pillow of the dying. [Ed. Rev.]

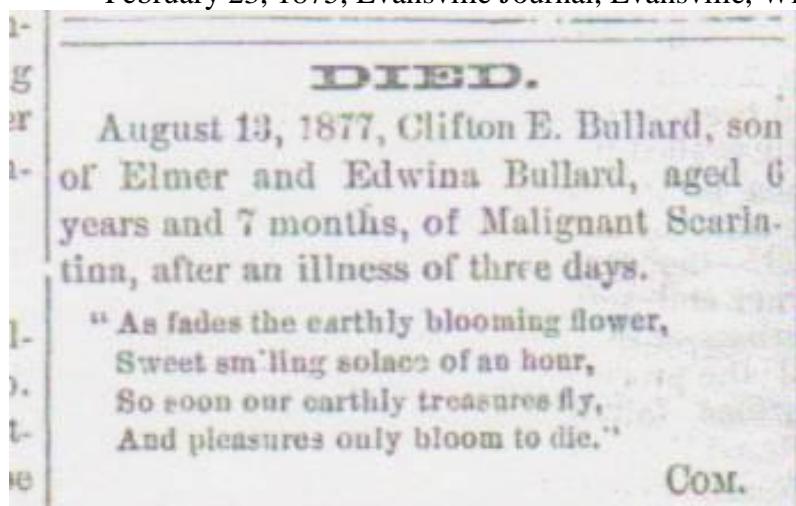



SAD! VERY SAD!

Doctors Smith and Roberts were called in great haste Wednesday noon to attend Mr. Hiram Bullard, at his farm a few miles east of town, who had been gored by a vicious bull. He was in the lot when attacked, the horn of the animal entered the right side of the neck, and made a wound some six or seven inches in length completely exposing the jugular vein and all the arteries of his neck, and injuring his right lung. The doctors had dressed the wound in the neck and were preparing to leave, when some medicine was administered, which caused him

to vomit, throwing up a large quantity of blood from his lungs, bursting open the wound in the neck, and he dropped dead in a moment. The internal injury was really worse, in view of the larger wound in the neck, than the doctors at first thought it to be, but were surprised to see him drop away so soon.

Mr. Bullard had lived on the farm where he died since 1846, coming from Henrietta, N. Y., when a young man. A few years ago, he bought a place on the corner of east Main and Cemetery streets, and made Evansville his home, retaining and attending to the business of his farm all the while. The news of his death spread rapidly over town, and everybody stood appalled with grief at so sudden and unlooked for casualty.

Mr. Bullard was about 58 years of age; was not connected with any religious body, but was always correct and honorable in his life practices. Funeral services held at the farm residence, Friday afternoon at 2:30 o'clock by Rev. Mr. Drown, of Union, assisted by Rev. Mr. Curry, of this place.

#### Obituary -- Hiram Bullard

Less than a year ago Stilman Bullard, a well known citizen died. Death has again entered this family and taken his brother Hiram. Hiram Bullard was born October 2d, 1825, in Monroe county, N. Y. He came west in 1846; returning east two years after and marrying his wife, Jane Ann Babcock. Settling on his farm a short distance from Evansville, by the force of thrift and industry he acquired, and brought to the present state of value, that fine farm of over one hundred and sixty acres, upon which two of his sons are living. Mr. Bullard was married three times. His first wife died in 1862. His second wife, to whom he was married in 1863, was Mary E. Butterfield of Fox Lake. Her death occurred in 1874. His last wife, who survives him, was Julia M. Wheelock, of Brooklyn.

Nine children were born to him, five of which had gone on before him to the other world. Eugene and Frank, sons of the first wife; Clarence and Elbert, sons of the surviving wife, are left. Honesty, integrity and frugality, essential to success in this life, characterized Mr. Bullard. He died in the midst of his work, and surrounded by the fruit of his labor. BURNED.—Mr. Dell E. Bullard, who lives on the Stiles farm a mile or more South-east of Evansville, had his house burned Wednesday night, Jan. 25, with nearly its entire contents.

It was not known to have been on fire until the roof falling jarred plastering off the room in which Mr. Bullard sat reading, and stepping out of doors found neighbors running towards his house and the whole upper part in flames. Rushing back as soon as possible he could save nothing but what was contained in a parlor bedroom. The fire occurred just before eight o'clock, and the family were preparing for bed. Mrs. Bullard had nearly disrobed and was just stepping into bed as the flames burst into the room. The house was a commodious farm residence and well furnished for its purposes. There was a small insurance, but the loss is rather a severe one, especially at this inclement season.

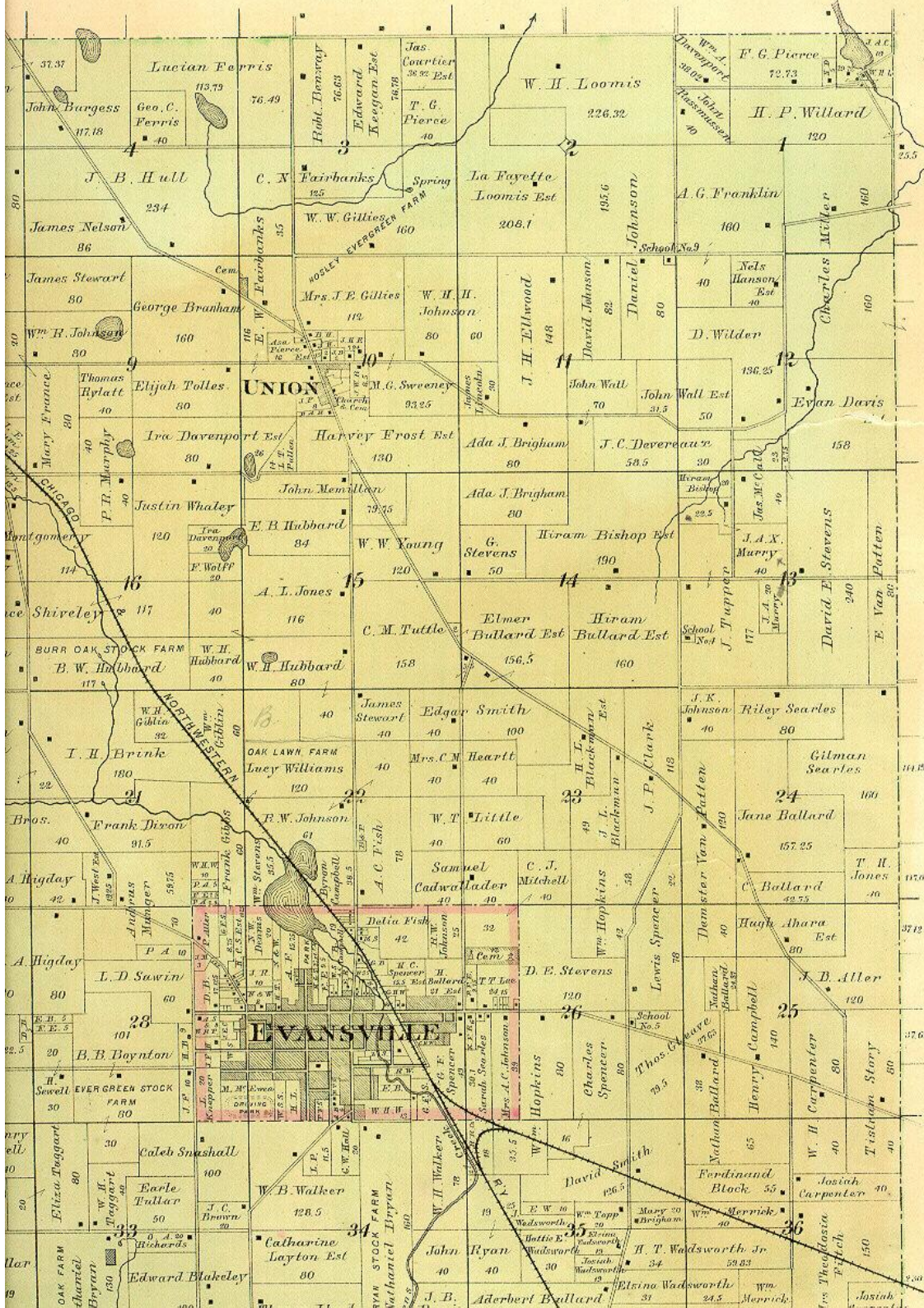

## Frank Bullard Has Market for Tooled Leather Articles Made at Farm Home

Hobbies begun to while idle hours often turn into a source of sideline income, and that is exactly what happened with the leather tooling hobby begun years ago by Frank Bullard, former Evansville resident now operating a farm near Paynesville, Minn.

It was rather natural that Bullard should become interested in leather tooling because 20 years ago following his departure from Evansville he was riding the range out in the Cody, Wyoming country and also near Pierre, So. Dakota.

Beautifully hand-tooled saddles and bridals, hand-tooled leather belts and hat bands, and hand-tooled leather wal-

lets are as much a part of the West as cattle and sheep.

Mr. Bullard learned the tooling art from a saddle maker in Pierre, and in later years as a hobby he tooled leather purses and other articles of leather for Mrs. Bullard and his three daughters.

Came the drouth years of the early 'thirties and the depression and Mr. Bullard did more and more tooling. Residents of the community who learned of his work ordered belts, purses, photograph album covers, bill-folds with lodge emblems tooled on them, or, in the case of state officials, with the state seal of Minnesota.

At a little desk in the Bullard living room this ex-cowboy now whiles away long winter evenings cutting lovely designs into the smooth surface of steer hide. During the last two years he has made more than 200 tooled leather pieces, and always there are orders for more.

Many of the fine tools he uses are bought from leather tool manufacturers, but those he uses most are of his own manufacture. "It is a luck combination," he says, "when hobbies can also be income producers. Mine has been a great help during the depression years."

## LAWRENCE BULLARD HAS OLD DOCUMENTS

(By Ruth Martin)

A family Bible dated 1855, 13 diaries of the early days, a marriage certificate dated 1848 and an old letter written in 1847 before postage stamps were used are among some of the things Lawrence Bullard, living near Evansville, has, that belonged to his grandfather Hiram Bullard. The letter was written by Lawrence's great grandmother to her son Hiram who was then living on the farm now belonging to Lawrence.

Hiram Bullard purchased this farm, located 2½ miles northeast of Evansville, Section 4 Union township, 111 years ago. He was born in Monroe county, New York in 1826. When he was 20 years old, in 1846, he came to Rock county, Wisconsin accompanied by his four brothers. They all immediately purchased farms of 160 acres each. Three of the farms adjoining each other. The other two were a short distance from them. Hiram's farm, now owned by his grandson Lawrence, is the only one of the five farms still owned by the Bullard family. They received the Century Award for the farm in 1946. They paid \$2.50 an acre for the farm in 1846.

Hiram married Jane Babcock, May 30, 1848 in Brighton, N. Y. She was a charter member of the old Baptist church in Union township having had her membership transferred from New York in 1848. Lawrence also has this document.

The old letter, yellowed with age, written in 1847 by their mother who remained in New York and written as only a mother could, one year after the 5 Bullard boys had settled in Rock county. She expressed her concern over her youngest especially the youngest one. She says "She wants him to write and open his mind to her as he was so young to go so far away to a new strange country."

Hiram kept diaries of the every-day happenings in detail, about the weather, crops raised and yield per acre, such as white wheat and oats. The oat yield was 1080 bushels on 20 acres.

He also wrote in his diary about the Chicago fire. The entry dated Saturday, October 7, 1871 (the date of the fire.) He says weather cool and smoky, but he did not hear of the fire until the following Tuesday, October 10, stating his father went to Evansville and heard about the Chicago fire. The diary states the next day October 11 they husked corn all day and had the "Chicago fire on the brain." Starting on Main st., it burned over 9 miles square in the heart of the city.

In 1846 the Bullards bought a threshing machine in Milwaukee, evidently one of the first in this part of the country. It caused quite a sensation when they hauled it home, coming on the Old Stage Route and threshing the farmer's grain on the way home to Evansville. Lawrence Bullard

has an old hand wrought iron-cylinder tooth taken from the old machine and also the bagger, when it gave way to a newer model.

Hiram was agent for John P. Manny's combination mower-reaper selling for \$150.00. This machine was manufactured over 96 years ago. He kept one of the illustrated circulars showing the machine and prices. It also states the mower-reaper combination had been demonstrated at Watertown, Wis., and Milenton, Wis., in 1861 (perhaps meant Mil-ton, Wis.) and several towns in Illinois.

in 1868, 89 years ago, Hiram built the white brick house that is on the farm today. It has 14 large rooms (26 rooms if closets, pantry and halls were counted). Four large chimneys carried away the smoke from the 7 wood-burning stoves required to heat the building. Some chimneys had 2 openings for stove pipes. It was no wonder the diary states the men folks are cutting wood on almost every entry date all winter. The house is very much the same as when originally built with the long windows and wide moldings on the casings.

The first crop of tobacco he raised was in the early days when

it was more of an experiment in this section of the country. They did not know much about raising it, so when they set out the first plants they would cover them partially with a few leaves to protect them from wilting in the hot sun. This crop proved successful but the price of 2 cents, a pound was refused. A little later he was offered 2½ cents a pound and he sold the crop.

Lawrence is the grandson of the original owner. He married Vinne Haynes, of Portage, 40 years ago. His father was Frank Bullard, the youngest of Hiram's 7 children.

The old homestead has provided much more than a good living for the 5 generations who called this farm home and is in a better state of cultivation than 111 years ago. Lawrence's son now does the farm work and lives with his family in another house on the farm.

# Game Highlights Homecom

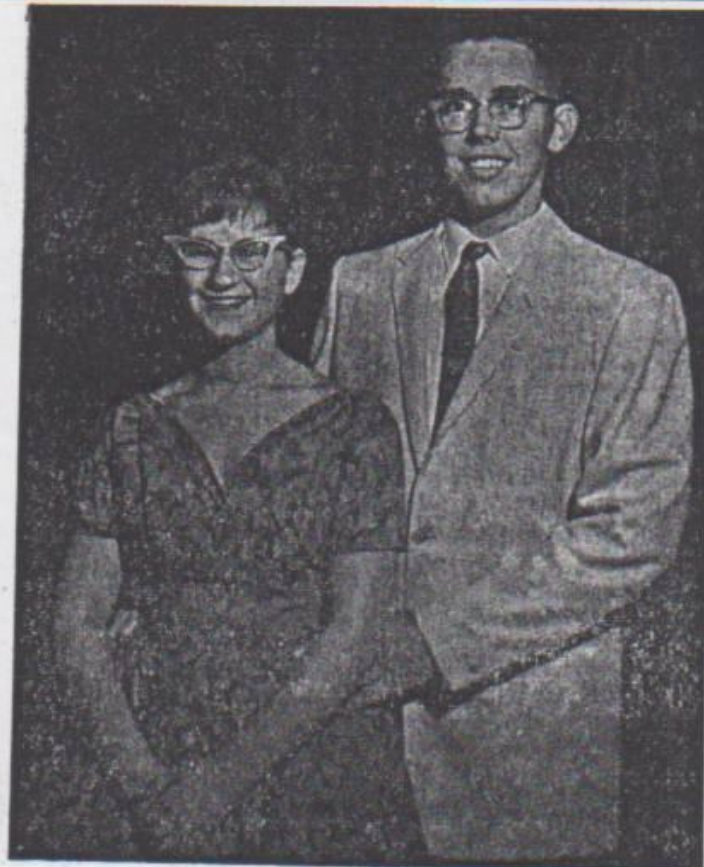
## Events Include Skits, Bonfire, Pep Rally, Parade and Dancing
